\$ 3.3 Million Low NitrogenLand Use Budget

On Monday 9 February a workshop was held with stakeholders to get their feedback on the decision making framework for the \$3.3 Million budget. Participants included representatives of StAG, Land TAG, Grow Rotorua, BOPRC, Farmer Collective, Te Arawa Lakes Trust. The purpose of the workshop was to inform decision making criteria, process and approach to spending the \$3.3 million. The workshop was not to inform what the money should be spent on or who should make the decisions on how the money was spent. Excellent input into all considerations provided. Paper with recommended framework and next steps to be presented to RTALSG in March.

Conversion and Incentives Scheme, this will be the first chance to see how the simplified approach is implemented. Opportunities have arisen where these three components are being spoken about at various events and details of other open forums will be sent to StAG as well as through media releases, the Lakes Programme database of contacts and other databases that we may have access to eg iwi, the Collective.

There are still a number of landowners concerned about how they will be affected by the proposed land use rules and support available, and it is quite hard to navigate the current website which is the main hub for information. There are no Fact Sheets available explaining the rules and given the cost to re-print and the risk of information becoming outdated, people should be directed to the website. In due time, the website will be changed to reflect the more simplified approach and to ensure it is easier to navigate and content is easy to understand.



Landowners New to Groundwater Boundary

A meeting was held 11 December 2014 at the Ngongotahā Hall by the Collective in association with BOPRC. About 25 landowners from 13 properties within the additional groundwater area attended. Presentations at the meeting were given by the scientists who helped define the groundwater boundary as well as Sarah Omundsen who discussed the proposed rules. A number of concerns were raised by those who attended as they have only just heard about the nitrogen limits.

Following that meeting, an updated contact list for those new to the groundwater boundary will be sought, a meeting to further explain the draft rules, including how Nitrogen Discharge Allowances will be calculated given there are no 2001-2004 benchmarks for the additional groundwater area will need to be held and a page addressing their specific concerns added to the website.
